

INVESTMENT CONTROL

Foreign trade law plays an ever-increasing role in cross-border transactions. Our team assesses whether transactions in Germany and other countries are subject to filing requirements under foreign direct investment law regimes. We prepare the filings and coordinate with lawyers from other jurisdictions as necessary.

- Providing strategic advice to foreign investors on foreign trade acquisitions and carve-out transactions
- Preparing legal due diligence assessments and providing support before and during investment reviews in the context of company acquisitions
- Assisting with and representing investors and vendors in negotiations with the relevant authorities
- Preparing applications for clearance certificates or ccorporate approvals

EMBARGOES AND SANCTIONS

The European Union and key trading partners have enacted a variety of embargoes and sanctions that affect supplies, services, and financial transactions. Our experts work closely with lawyers from other affected jurisdictions to review contracts and their implementation under national and European law. We make the necessary filings with the competent authorities and represent clients in administrative proceedings.

- Providing advice on embargo and sanctions law issues applicable to the client's foreign business in affected countries (e.g. Russia, Iran, Libya, etc.) or with affected individuals
- Assessing the compliance of individual contracts and transactions with sanctions
- Advising on the sale and delivery of certain goods to countries affected by sanctions or to affected individuals
- · Assisting with financial transactions involving sanctioned countries or affected individuals
- Providing advice on the inclusion of certain individuals and companies in the list of persons affected by sanctions, including providing representation in administrative proceedings and before the European courts

- Examining the agreement for the provision of services to a subsidiary of a Libyan holding affected by several sanctions and advising on the structuring of services and the provision of hardware and software in the telecommunications sector

EXPORT AND IMPORT CONTROL, CUSTOMS

Many goods are subject to national and European import and export controls and the payment of customs duties. Our experts advise on the design and implementation of supply agreements under national and European law. We represent clients before the competent authorities in administrative and legal proceedings.

- Designing and assisting with the implementation of cross-border import and export transactions
- Advising on export trade, especially on export licences and export control law issues

INTERNATIONAL PAYMENTS

Reporting obligations for companies and private individuals, such as for foreign payment transactions, also fall within the remit of our foreign trade law team. Companies are often unaware of such requirements, frequently because of the field of business, size, or experience of the company. Various legal implementation issues arise for imports into the customs territory of the European Union. Our team helps clients implement the applicable reporting procedures and communicates with the relevant authorities.

- Advising companies on ongoing compliance with reporting obligations under the German foreign trade and payments regime
- Providing legal support for voluntary disclosures regarding violations of reporting obligations
- Providing representation in the event of violations of reporting obligations

- Assisting a start-up company in the energy sector with the establishment and implementation
 of an internal compliance structure for monitoring payment transactions that might be subject
 to reporting obligations, as well as advising on the implementation of the requirements to report
 foreign sales to the German Federal Bank in the future
- Advising an IT start-up on making voluntary disclosures to the German Federal Bank and the responsible customs office in relation to violations of the reporting obligations for foreign sales
